Release & Waiver of Liability and Assumption of Risk

In consideration of being allowed to enter the play area and/or participate in any party, activity, and/or program at Kiddie Crusoe, LLC the undersigned, on their own behalf, and on the behalf of the participant(s) identified below, acknowledges, appreciates, and agrees to the following conditions:

- 1) I attest that I am the parent or legal guardian of the participant(s) undersigned, or that I have obtained permission from the parent/legal guardian of the participant(s) undersigned to execute this agreement on their behalf and agree to attend to and monitor the activities of all participant(s) undersigned such that all activities are age and ability appropriate;
- 2) I agree that the participant(s) undersigned and I shall willingly comply with all stated and customary terms, posted safety signs, rules, and safety instructions and directions by Kiddie Crusoe and its staff and personnel as conditions for use of play equipment and participation in any party, event, activity, and/or program. In addition, if I observe any hazards during my stay or participation, I and the undersigned will cease all activity near or around said hazard and immediately alert the nearest Kiddie Crusoe employee or official; Additionally, I agree that all undersigned and I shall use all play equipment and items appropriately, adhering to all play rules, as well as size and weight limitations; Furthermore, I understand and agree that I will be solely responsible for any and all costs to repair or replace any damage to the facility and/or the equipment therein incurred by the undersigned and myself outside of normal wear and tear. I agree that I am aware of the proper usage of inflatable attractions and will supervise and direct all participant(s) undersigned accordingly. Furthermore, I understand and agree that no outside food is permitted in the facility and will ensure that any food purchased from the facility will be consumed in designated eating areas only.
- 3) I, for myself, and the participant(s) undersigned, acknowledge and understand that there are dangers and risks associated with the activities at/by Kiddie Crusoe, LLC and agree to assume all risk of personal injury, including the potential for paralysis and death, and I, on behalf of myself and the participant(s) undersigned, knowingly and freely assume all such risk, both known and unknown, including those that may arise out of negligence or other participants;
- 4) I, for myself, and the participant(s) undersigned, and on behalf our heirs, assigns, administrators, personal representatives and next of kin, hereby agree to indemnify and release and hold harmless Kiddie Crusoe, LLC, its affiliates, officers, members, agents, employees, other participants, landlord, equipment manufacturers, and sponsoring agencies against any and all claims, injuries, liabilities, damages, or costs to person or property arising out of or related to our participation in any and all Kiddie Crusoe programs, activities, parties, the use of play area and/or play equipment to the fullest extent of the law.
- 5) This release and waiver extends to all acts of negligence by Kiddie Crusoe, LLC and is intended to be as broad and inclusive as permitted by the law, and if any portion of this agreement is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
- 6) I, for myself, and the participant(s) undersigned, consent to the publication of personal pictures, which may be taken by Kiddie Crusoe, LLC personnel or their representatives. Publication may include, but is not limited to, marketing materials and websites.
